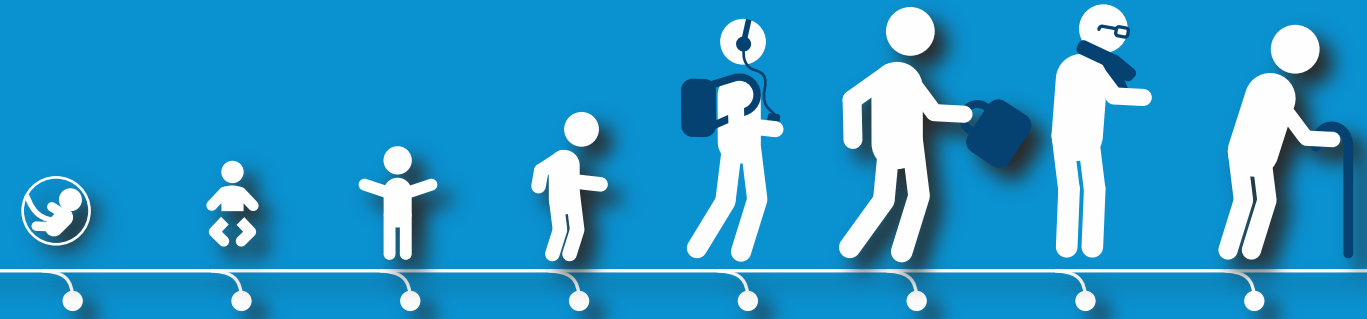

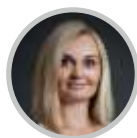
Amendment to Law No. 48/1997 Coll.

The submitted Amendment to Law No. 48/1997 Coll. (on public health insurance) is the result of work carried out at the Czech Ministry of Health over the course of many months. It was proposed and worked on by insurance companies, doctors, patients and representatives of the medical device industry. The Association offers consultancy services regarding the practical implementation of new rules for reimbursements – introducing new products, rules for pricing, and transfer of current products to the new record-keeping system in the SUKL's management.

Code of Ethics

We know that compliance with legislation does not necessarily guarantee ethical business practices. Direct support of healthcare workers who participate at conferences and other events hosted by third parties is considered to be the most controversial interaction between industry representatives and their partners. A newly adopted Code of Ethics (effective from 1 January 2018) makes these contacts transparent. We direct, educate and motivate all healthcare entities to abide by the ethical principles.
